Formation of the Produce Safety Network




- Implementation of Produce Safety Rule provides unique opportunities and challenges

 - Regionally based
 - Collaborate and communicate with regional partners
 - Provide outreach and technical assistance tailored to the unique conditions in the region

- FDA Produce Safety Network (PSN) built to support the efforts of farmers, state regulators, and other key stakeholders to implement the Produce Safety Rule
- The PSN is comprised of two parts of FDA:
 - Center for Food Safety and Applied Nutrition (CFSAN)
 Produce Safety Experts
 - Office of Regulatory Affairs (ORA) specialized investigators




Do you have a question/feedback for the Produce Safety Network?

- Stakeholders should identify and contact the CFSAN Produce Safety Expert for their assigned state if they have a question. The Produce Safety Experts from CFSAN will field most questions that come to the network from external stakeholders.
- The Investigators from ORA will handle questions and communications that occur during inspections and investigations.



The outcomes of this cooperative agreement program are to:


- Advance efforts for a <u>nationally integrated food safety system (IFSS)</u>
- Plan, establish, and/or enhance state and territorial produce safety programs.
- Encourage the safe production of fresh fruits and vegetables.
- Promote understanding and compliance with the requirements of the Produce Safety Rule.

Applicants are state/territory government food agencies that do or could have jurisdiction for commodities in the Produce Safety Rule



I'll be helping develop strategies to implement the Produce Safety Rule. I'll be working closely with the Division of Produce Safety, which has been on the frontlines of FSMA rulemaking and implementation, and FDA's Produce Safety Network that has stationed experts across the country to support farmers and state regulators **Samir Assar -**Director of FDA's Div. Produce Safety in CFSAN

"It's important to note that routine inspections under the Produce Safety Rule will not begin until the spring of 2019 to give both farmers and state regulators more guidance, training, technical assistance, and planning and ensure that they have the tools they need."

"PSN members are actively working with state produce program staff to learn more about the challenges faced in their regions. One way they're doing this is by interacting directly with farmers. In 2017, PSN and state staff participated in educational visits to 117 U.S. farms to listen to the challenges faced by farmers, learn about unique growing conditions and practices, and address questions and concerns about the Produce Safety Rule."





Outreach and Technical Assistance

ORA PSN communications:

 With state partners and industry for OFRRs, inspections or investigations, work planning (state partners only)

CFSAN PSN as a resource for external stakeholders

 Includes policy and rule interpretation, scientific support for state and industry partners

135 PSR interpretation questions answered*

PSN attended ~80 outreach events in fiscal year 2017





Educational Farm Visits

- Response to stakeholder concerns about FDA knowledge of growing conditions/practices
- Help PSN interpret PSR, develop guidance, conduct regulatory work
- PSN has conducted 39 farm tours, involving 117 farms*



On-Farm Readiness Reviews (OFRR)

- FDA is working with the National Association of State Departments of Agriculture (NASDA) to develop a voluntary on-farm readiness review program
- Partners:
 - Cooperative Extension (Land grant institutions)
 - University of Florida, Michigan State, NC State, Rutgers (NJ), and Produce Safety Alliance
 - State Agriculture Departments
 - Oregon, North Carolina, Michigan, and Vermont
 - FDA
 - Center for Food Safety and Applied Nutrition
 - Office of Regulatory Affairs
 - Office of Foods and Veterinary Medicine
 - USDA
- "If a farmer chooses to participate, a team that could include state and FDA regulators and educators would visit the farm to offer insights, advice and technical assistance, and to answer any questions that the farmer may have about his/her specific operation."
